NOTICE TO EXHIBITORS

FEES: The fee for Obedience Regular Classes, Alternate Titling Classes, Optional Titling Classes and Rally Regular Classes is \$30.00 for the first entry of each dog, **per trial**, per day. Each additional entry of the same dog, same trial, same day is \$22.00. Obedience Non-Regular Classes are \$20.00 each entry, per trial. **Please remember there are four distinct trials.** Entry fee includes the AKC \$.50 Recording and \$4.00 Event Service fee for Obedience and \$4.00 Event Service fee for Rally.

Telephone, email, or faxed entries will not be accepted.

ENTRIES close Wednesday, October 7, 2026 at 6pm. All entries must be on an Official AKC Entry form, completed and signed, and must include the Agreement and Instructions on the reverse side. Entries will not be accepted without the proper form, signature(s), fees, or if the entry specifies any condition as to its acceptance. Incomplete, inaccurate, or illegible entries will not be accepted. Returned checks do not constitute a valid entry. A \$25.00 fee will be charged for a returned check. **Please type or print legibly.** A confirmation e-mail will be sent to each exhibitor. Please check Junk mail.

LIMITS: Saturday and Sunday trials will be limited to a total of 8 hours of judging time per judge per day. Obedience Regular Class entries will be given first priority followed by Alternative Titling Class entries then Optional Titling Class entries. Entries will be taken in the order received until the 8 hour time limit per judge is reached or entries close.

JUMP HEIGHT: All classes requiring jumps will be arranged in jump height order. Running order will be tallest to smallest. **If you are entering any of these classes jump height is a required part of your entry.** Please refer to **AKC Obedience and Rally Regulations** for the description of classes, eligibility, and proper jump heights.

Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.

ERRORS ON ENTRIES: Owners are responsible for the accuracy of the information required on the entry form. Changes, additions, or corrections to an entry, entry substitutions, or cancellations by the owner must be received in writing by the Trial Secretary prior to the closing date of the trial. Other means of notification will not be accepted.

REFUNDS: Entry fees will not be refunded after the closing date, due to errors, omissions, cancellations, or for duplicate entries. A refund of entry fees will not be given in the event a dog is absent, disqualified or excused by a veterinarian or judge, or barred from competition by action of the Trial Committee; or if the trial cannot be opened or completed by reason of riots, civil disturbances, extreme and/or dangerous weather conditions, or any emergency or other cause beyond the control of the Club.

The entry fees per day per trial less \$7 will be refunded for bitches that come in season after the closing date. A written request from the owner accompanied by verification from a veterinarian, must be received by the Trial Secretary at least 30 minutes prior to the start of the first day of the trial. Bitches in season may not be at the show site at any time.

JUDGING: Exhibitors are responsible for being ready at the ring gate for judging. The Judging Program will be sent to exhibitors approximately one week prior to the Trial. Judging schedule conflicts should be resolved with the judge at the trial, prior to the start of the class. Neither the Trial Secretary nor any other individual is obligated to call or notify exhibitors when they are due in the ring for judging. Judges are not required to wait for any exhibitor. Dogs need be present only for scheduled judging and will be released if not needed for further judging.

SHOW SITE: All dogs must be held on a leash or confined to a crate except when in the ring for judging. Dogs must be on a leash when being exercised, trained or when warming-up. Please maximize available crating space but do not crate within 10 feet of the ring gates. Dogs must be removed from the building immediately following the end of the Trial. MADOC reserves the right to remove any dog in distress in a parked vehicle or crate.

NOTE: Due to children being on-site Friday afternoon, you must wait to set up on Saturday morning.

Please keep the grounds clean by picking up after yourself and your dog. Please make sure you dispose of 'poop' bags in the trash containers provided. Please keep your crating area, the trial site, RV grounds, and motel rooms and grounds clean so we may continue to be welcomed at these facilities.

CONDUCT: It is expressly understood that all owners/agents/exhibitors are solely responsible for the behavior of their dogs and/or children. Any person(s) whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases no refund of any fees/monies paid will be made. All owners/agents/exhibitors and other persons attending these trials hereby waive any claim against the club or its agents, for any losses, damages, or injuries affecting self, dogs, children, or personal property.

WARM-UPS and training should be conducted in accordance with Chap 2, Sect 26 of the AKC Obedience Regulations.

TRANSFERS will be allowed at this trial.

CONCESSIONS: No concessions on-site. Several fast food restaurants are located within minutes of the trial site, or you may bring your own food.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
